<p><b>Heat Pump – 57 Units</b></p> <ol style="list-style-type: none"> <li>1. To ensure tenants are notified through OAHS prior to beginning work.</li> <li>2. Supply a ductless Single-split Air Source Heat Pump for Single dwelling units. Installed as per manufactures installation specs.</li> <li>3. Supply a ductless Multi-split Air Source Heat Pump for Duplexes, Triplexes &amp; Quadplexes. Installed as per manufactures installation specs.</li> <li>4. Exterior unit to have 3 sided protection.</li> <li>5. Wireless remote with wall mounted beside interior unit.</li> <li>6. Unit must be Energy Star rated to meet energy efficiency requirements.</li> <li>7. Unit must be a Cold Weather Heat Pump and have a minimum temperature rating of -25 C.</li> <li>8. Units must be sized appropriately for size of house to be used as supplemental heat.</li> <li>9. To prevent snow from blocking airflow over the coil and to permit defrost water drainage, the unit should be raised or placed on a stand that raises it 30 to 60 cm (12 to 24 in.) above the ground. The stand should be anchored to a concrete pad, which in turn should sit on a bed of gravel to enhance drainage.</li> <li>10. Refrigrant lines must be insulated to minimize unwanted heat loss and to prevent condensation.</li> <li>11. Estimate must also include any electrical work to accommodate the installation of the Heat pumps, including additional breakers, or changes to the electrical Panel.</li> </ol>
